Two Units Pull State Duty Following Savage Tornado

Two Batteries of the Kentucky Army National Guard were called into action on June 9th by Major General Arthur Y. Lloyd, Adjutant General of Kentucky, when a savage tornado struck the small river town of Ravenna. The tornado caused an estimated \$1,000,000 damage and injured fifty people.

A great number of the injured were children, attending Daily Vacation Bible School at the Ravenna Christian Church which was totally destroyed when the roof of the large two story structure was blown off and the walls

of the building caved in.

Alerted for duty were the Headquarters Battery of the 3rd Howitzer Battalion, Richmond, Ky., commanded by 1st Lt. Charles C. Combs, and Battery B, located in Ravenna, commanded by Capt. Robert T. Walker. Both units are part of the 3rd Howitzer Battalion commanded by Lt. Col. James W. Stocker of Richmond.

State Police, National Guardsmen and the local officials immediately took round the clock control of traffic and

Architects Employed For New Armories

Five architectural firms have been named by the Kentucky Department of Finance for the preparation of plans for five new National Guard Armories to be built in Hopkinsville, Monticello, Campbellsville, Glasgow and Marion, Kentucky. The announcement was confirmed by Lt. Col. Calvert P. Small, Director of the Facilities Division for the Kentucky Department of Military Affairs.

Congress has authorized the construction of these new armories by passing House Resolution 5000. The necessary appropriations for construction of the buildings are expected to be approved and authorized by Congress sometime in August.

Architects named for the construction projects are: Mr. Lawrence Casner, of Madisonville, for construction of an armory at Hopkinsville; McCulloch & Bickel, of Louisville for the Monticello

Guard Units Ready-Lloyd

The overall state of the Army and Air installations was described as being in a "high degree of combat fitness and readiness," by Maj. Gen. A. Y. Lloyd May 13 at the closing session of the 30th Annual Conference of the Kentucky National Guard Association.

"I am proud of the Kentucky National Guard as I've never been before," Lloyd, State Adjutant General, told 300 members of the association who earlier heard Gov. Bert T. Combs comment on the efficiency and training used in the individual units throughout the state.

Lloyd and Combs spoke at the closing session of the meeting at the Phoenix Hotel in Lexington.

Also during the closing business session, the group passed a resolution

All National Guardsmen are encouraged to take advantage of the opportunity to advance their military education by attending one of the various Service Schools available to them through the Guard.

Lt. Col. Edward H. Milburn, State training officer, pointed out recently that the new school funds for the fiscal year starting this month have been allotted to Kentucky and any officer or enlisted man who might better himself and his unit by attending a service school should apply to the Adjutant General's Office as soon as possible.

In many cases, graduation from certain schools is a requirement for the promotion of the Guardsman.

everyone, who requests and requires additional training, to an appropriate service school as long as funds permit, and if necessary additional funds will be requested.

Last year, the Kentucky National Guard used \$73,000 to send personnel to the various courses.

sive exercise has been held within the continental United States and not within the bounds of a military reservation since the "Louisiana" maneuvers in 1941.

Approximately 30,000 Army personnel, supported by some 400 Reconnaissance Fighter and Troop Carrier Aircraft will mass at bordering "dispersal" bases and will begin the exercise on the morning of August 6. The exercise will end August 20.

Kentucky will furnish 15 officers and 45 airmen. Eight aircraft and support equipment are being programmed to fly a minimum of 12 reconnaissance sorties during each day of the training exercises.

THE AG SPEAKS

At the time of this writing, I have just returned from a visit to Lackland Air Force Base, San Antonio, Texas. The mission of the Lackland Military Training Center is to provide individual military, technical and physiological training for airmen, officer and civilian employees of the USAF, the Air Reserve, Air National Guard and other agencies including Foreign Nationals.

The process of transforming young men into skilled airmen to man Air Force installations throughout the world begins at Lackland. Due to this fact, the quality of US Air Forces during the next ten or twenty years depends much on what is being done at Lackland today.

The purpose of my visit was to attend the 1961 Air National Guard Day at this great Air Force Base. I was glad to have the opportunity of meeting the Kentucky Air Guardsmen who are now receiving their basic training on that Base. They are a fine group of young men whose work at Lackland reflects credit upon themselves, as well as the Kentucky Air National Guard.

I was glad to learn that Air Guardsmen arriving at Lackland average about two years higher in educational qualifications than the average of all the trainees sent there. I was also informed that when Air Guardsmen arrive, they have a better military bearing than the average trainee. It behooves us in the Kentucky Air Guard to see to it that our trainees arriving at Lackland have complete orientation and instructions prior to leaving Shewmaker Air Base. Also they should arrive clean and neat in appearance with clothes pressed and shoes shined.

In view of the limited number of non-prior service personnel that can be recruited, every effort should be made to select those young men with sufficient educational background and experience to make the most of their training as potential airmen.

I want to congratulate the Kentucky Air Guard upon the type of trainees that they have sent to Lackland in the past and to encourage them to maintain this high standard in the future.


Kentucky Air Guard To Participate In "Swift Strike"

The Kentucky Air National Guard will participate early in August in the joint Army-Air Force Exercise Swift Strike. The exercise will be the largest full scale peacetime field training maneuvers ever to be held in the United States.

The Kentucky Guard — the 123d Tactical Reconnaissance Wing, commanded by Lt. Col. William H. Webster, will deploy the 165th Tactical Reconnaissance Squadron to an air base in the Carolinas to fly sorties in support of the exercise.

The exercise, which will be held almost completely on civilian domain, will range across the area of both North and South Carolina.

It will be the first time such a mas-

Guard Alerted For Sturgis Flood Duty

Three units of the Kentucky Army National Guard were put on stand-by alert on May 15th when rising waters from the Trade Water River caused the evacuation of approximately 30 families in the low lying areas of Sturgis, a small Western Kentucky community.

The units, alerted for possible flood duty by Major General Arthur Y. Lloyd, Adjutant General of Kentucky, were Hq & Hq Co, 2nd Medium Tank Battalion, Owensboro, commanded by Capt. James L. Brady; Co. C, 2nd Medium Tank Battalion, Henderson, commanded by Capt. Thomas E. Lett, and Co. D, 3rd Medium Tank Battalion, Marion, commanded by Capt. Edwin A. Runyon.

Other than the use of several National Guard trucks to transport surplus food and clothing to the flood victims, the units were not called to duty since State Police, Civil Defense and Local officials were able to perform the necessary emergency duty.

The river, rising an estimated nine feet above flood stages caused approximately \$100,000 damage. The swollen Ohio River caused flood damage in Western Kentucky and Tennessee, Southern Illinois and Southeast Missouri.

Phelps - A-Plenty

First Sgt. H. G. Wilson, taking the Phelps situation in his stride, claims the company's attendance will never slump if the Phelps are there.





In future years, as funds become available, seven other Guard armories will be in line for construction. These armories will be located at Lexington, Richmond, Bowling Green, Ravenna, Russellville, St. Matthews, and Carlisle.

There is an L-20 Army airplane at the Aviation hangers in Frankfort that generally is no different from any other L-20 except that this one carries a lot of pride and personal accomplishment with it each time it departs on routine training flights.

This special L-20 was originally scheduled for salvage after a crash during a landing at Flemingsburg in April of 1960. A survey by an Army Maintenance Depot announced that damage was so extensive that the plane was "economically beyond repair." After

persistent requests to the National Guard Bureau, authority was granted for the plane to be rebuilt by the Army Aviation Section of the Kentucky National Guard.

The whole job, including numerous delays in obtaining parts, took exactly four months. Parts had to be shipped from Canada, California, Alabama, and Pennsylvania.

"No Adjustments Required"

The first test flight was accomplished by Major John Faulkenberry on June

15th.

After a thorough inspection of the craft by personnel of the New Cumberland Depot located in Harrisburg, Pennsylvania, Aviation Section members received with a grin the report, "No adjustments required."

Members of the Army Aviation Section who had a part in the rebuilding project, which is normally performed only by Depot Maintenance, were Major John F. Faulkenberry, MSGT Olan L. McGregor, MSGT Kelly Barker Jr.,

Hughes Named Honor Graduate In 1961 OCS Class

George F. Hughes, Jr., of Middlesboro, was selected as Honor and Distinguished Graduate at formal graduation ceremonies of the Kentucky National Guard's Officer Candidate Class No. 3-61.

In addition, Hughes was awarded the National Guard Bureau's "Erickson Trophy," a plaque from the National Guard Association of Kentucky and The Association of the United States Army Service School Plaque.

Twenty candidates received their graduation diplomas and a commission as a 2nd Lieutenant during the ceremonies held at the National Guard Armory here June 30th.

Principal speaker for the occasion was Brigadier General William R. Buster, Assistant Adjutant General of Kentucky, who charged the new officers with a "dual responsibility of leadership, not only in the military but also in your community."

General Buster told the graduates that they were receiving their commissions at a "propitious time" since congressional action has now created greater opportunity for advancement of the young proficient National Guard officer. The General also predicted a 10% increase in National Guard strength by 1964.


